Included with this application is a numbered layout of the booth spaces available. **Booth spaces are strictly assigned on a first-come, first-served basis when your completed application is received.** Once you have been assigned a booth, you will receive confirmation by e-mail or phone.

LOCATION: 4th Street between Main Street and Maple Street – Yukon, OK
BOOTH DIMENSIONS: Booth spaces are 10' x 10' square
BOOTH RENTAL FEES: \$100.00 Yukon Chamber of Commerce Members / \$150.00 for Non-Members
PAYMENT METHODS: Cash, Check, Credit Card. NO REFUNDS after 9/21/26 – event is held rain or shine.
- **Non-members must send booth payment in full with the completed application.**
 - **ONLY Chamber members may be invoiced. All booths must be paid by 9-21-2026.**

RULES

Electricity is limited to select booths and has an additional charge of \$20 - call our office for details. Generators are permitted, but if you will be using a generator, you **MUST** contact the Chamber office by phone prior to the event.

You CANNOT give away or sell items such as water, popcorn, cotton candy, etc. that is for sale at other locations. Pre-wrapped candy/food and promotional items are acceptable.

Booth assignments will be based on the date the applications are received. Chamber members can request to be invoiced for their booth. All booths must be paid in full by September 21, 2026.

VENDOR SET-UP

Saturday, October 3, 2026 from 6:00 a.m. to 7:45 a.m. (Streets are closed at 8:00 a.m.)

Booth vendors are responsible for bringing all equipment and supplies for your booth. After unloading, please move your vehicle from booth area. For the safety of those attending the festival and other vendors, we ask that you **DO NOT** bring your vehicle in the booth area between 8:00am – 3:00pm during the Czech Festival. Due to traffic congestion, **all vendors should have their booths set up by 7:55 a.m. on Saturday, October 3, 2026.** The deadline for cancellation and refund of booth rental fee is September 21, 2026. After this date, NO REFUNDS will be given. The Czech Fest is held "rain or shine", so be prepared. Vendors are responsible for collecting and paying sales tax to the Oklahoma Tax Commission.
